If you (the “student”) are applying for a place on the Lightning Process training programme, and you are planning to bring a carer, partner or parent (a “facilitator”) to sit in with you and support you during the training process, please read the following information, and ensure that they complete this form in full.

If you do wish to bring someone to help you learn please choose them very carefully.

Just because they are your carer, partner or parent and care deeply about you and your future, that does not necessarily mean that they are the best person to help you learn what you need to from the training.

If you do choose to bring someone (and many people in fact choose not to), they will need to complete a separate application form to yours (which can be found in our application forms section), so we can assess whether they will be suitable to support you in your learning, and decide if it is appropriate for them to attend.

They will need to be someone who is fully supportive of you in understanding and applying the training, someone who is ready to leave their preconceptions and beliefs behind, someone who is positive and inspires you.

The person that you choose to be your supporter / facilitator will need to read the information below.

Understanding the training programme and the role of the facilitator

How the training is conducted

Much will be demanded from you and the student over the three days of the seminar, but if you both take on the challenge then the rewards are extraordinary.

Your trainer has a very demanding role during the seminars. They have to not only present the material but also manage and assist you both as you go through that very challenging process. There are certain ground rules and understandings that will make the training easier for both of you and them.

Your trainer is completely committed to your success. As a result:

- They won't tolerate any behaviours from you or your student that prevent your student from getting the success that they deserve.
- They will deliver no-nonsense, honest and essential feedback, to both you and your student - do not mistake this as not caring.
- They will not always say what you want to hear. If what you, or your student, are doing is going to cost your student their success they will tell you, or your student, even if it risks you being annoyed with them.

That's how committed they are to the student's success.

Training and payment details

Training seminars are held regularly in west London. The training programme is held over three consecutive days. The course fee is £700.00 (GBP) to learn in a small group, and includes support material. Payment must be made **in full in advance of your training**; full details on how to make your payment will be provided upon your acceptance to the Phil Parker Lightning Process training programme with Positive Change.

Conditions of payment

Fees become payable one month prior to your appointments to confirm your place on the course. Fees cannot be refunded in the event of a cancellation on your part. This is because we run small group trainings with limited spaces. If you take up a space and cancel, no one else will be able to fill once the course starts.

Ownership

All documents you receive as part of your training constitute an intellectual property and are not to be reproduced, sold or distributed in any way.

Certificate of attendance

From August 2008 onwards, upon your successful completion of the course you will receive an attendance certificate from your trainer. We foresee that, over time, taking a Phil Parker Lightning Process training seminar will be considered a valuable component of an individual's life and work skills. The certificate will act as a reference that you attended the seminar for personal development, which can then be presented to future employers as evidence of your Phil Parker Lightning Process training attendance.
